



St. Mary's Episcopal Day School's Tuition Assistance Application:

A completed tuition assistance application must be submitted to the St. Mary's Episcopal Day School Head of School with all requested accompanying paperwork. The Tuition Assistance Committee, which consists of the Head of School and two additional school board members, will review the application information and determine eligibility. The committee will make a recommendation to the school board for board approval.

All information received during the tuition assistance application process is confidential and will be used by the committee strictly for determining eligibility for tuition assistance.

In order for your application to be considered you must:

- Submit the completed application to the Head of School
- Include a copy of Rental Lease or Mortgage Payment
- Include a copy of significant bills, such as car payments, utility bills, etc.
- Proof of income for All Adults in the Household to include:
A copy of your last two month's pay stubs or last month's bank account statements showing disability, unemployment, social security, child support or other income and last year's Tax Return.

Financial need is a prerequisite for scholarship eligibility based on availability of funds. Once you have turned in your completed application and documentation you will be notified of the board decision following the next school board meeting.
